NEWS RELEASE

Incident Date and Time: Saturday March 3rd, 2018 at approximately 1453 hours

Location: The areas of Tanforan Mall, Sneath Lane and El Camino Real in San Bruno

Type of Crime/Incident: Possession of a stolen vehicle, resisting arrest, hit and run, drug possession, warrant arrests, amongst others.

Suspects information: Charles Bradshaw an 18 year old from San Francisco, a 17 year old juvenile, a 16 year old juvenile and a 15 year old juvenile all from San Francisco.

Summary:

On the above date and time, agents of the San Mateo County Vehicle Theft Task Force were investigating a stolen vehicle with the assistance of the Daly City Police Department at Tanforan Mall in San Bruno. The vehicle was reported stolen out of Benicia California. During the investigation, agents saw several individuals run out of Tanforan Mall and enter the stolen vehicle. Prior to agents approaching the stolen vehicle and its occupants, the stolen vehicle was driven out of the parking lot at a high rate of speed. While the stolen vehicle fled the scene, it struck numerous vehicles on Sneath Lane. The vehicle came to rest at the Shell gas station at the corner of Sneath Lane and El Camino Real in San Bruno. All the occupants of the vehicle fled on foot. Daly City Police Department's K9 unit apprehended one suspect. After a short foot pursuit, two of the other occupants were arrested as well. The fourth suspect, who was identified as the driver of the stolen vehicle, was arrested by the Daly City Police Department later in the evening on the roof of a neighboring business.

The suspects are also being investigated by numerous agencies for burglaries and robberies in several jurisdictions in San Mateo County. The San Bruno Police Department responded and conducted several accident investigations due to the actions of the driver of the stolen vehicle.

The driver of the vehicle was a 17 year old juvenile from San Francisco. He was arrested for vehicle theft, possession of a stolen vehicle, resisting arrest and for multiple hit and run collisions. Charles Bradshaw 10/4/1999 from San Francisco was arrested for possession of a stolen vehicle, drug possession, resisting arrest and for committing a felony while out on bail. The third passenger, a 16 juvenile from San Francisco, was arrested on a warrant issued for terrorist threats. The fourth passenger, a 15 juvenile from San Francisco, was arrested on a warrant issued for assault with a deadly weapon and trespassing.
